Reservations and Payment:

A deposit of \$500 per person is due upon confirmation. Full payment is due 90 Days prior to departure.

Prices Include:

- Air from Vancouver to Las Vegas on Westjet
- Pre-assigned seating and 1 checked bag per person on Westjet
- 3 nights accommodation at The Excalibur Resort & Casino (Resort Tower)

Changes:
